

# BYLAW NO. 07-2022

## RURAL MUNICIPALITY OF ANTLE NO. 61

### A BYLAW OF THE RURAL MUNICIPALITY OF ANTLE TO FIX THE RATES TO BE CHARGED FOR THE USE OF WATER AND TO FIX THE RATES TO BE CHARGED BY SERVICE CHARGE FOR THE USE OF SEWER FOR THE SPECIAL SERVICE AREA KNOWN AS ANTLE


The Council of the Rural Municipality of Antler, in the Province of Saskatchewan, enacts as follows:

1. The charges to be paid by the water user whose water service has been turned on shall be those set out in Schedule "A" attached; provided, however, that the minimum shall be payable in every case whether or not any water is used.
2. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a service charge in accordance with Schedule "B" attached.
3. Accounts for water service and /or sewer shall cover a period of 3 successive months, and shall be rendered on or before the first day of the rendering period. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the period of thirty days, the water service may be cut off. When the water service is cut off, it shall not be turned on until all arrears have been paid, together with a fee of \$200.00 to cover the expenses of disconnecting and re-connecting the water supply.
4. Bylaws 13/2017 is hereby repealed.

THE rates, charges, tolls or rents contained in the bylaw shall come into force and take effect on January 1<sup>st</sup>, 2023 with approval being issued by the Local Government Committee.


